 the city as they were at fault. (Motion by councilwoman Johnson, 2nd councilman Vanderlip, all
 in favor)
- Gray & Osborne submitted Main Ave. Sidewalk Progress Estimate 4 that includes final payment and change order #5 (stated above). Mayor Mortensen stated the city has to pay the contractor and he is speaking with G&O regarding the additional asphalt and partial reimbursement from them for charges. (Motion by councilwoman Johnson, 2nd councilman Cooper, all in favor)
- Council approved changing the city credit card account to Security State Bank. (Motion by councilwoman Johnson, 2nd councilman Boyer.
